BY SIGNING THIS, YOU ARE ENTERING INTO A BINDING CONTRACT WITH NORTH COUNTRY AUCTIONS, LLC AND YOU, THE BIDDER, SHALL ABIDE BY THE FOLLOWING TERMS AND CONDITIONS

- All items are sold as is, where is, without any warranties or guarantees, either expressed or implied, including but not limited to merchantability or fitness for a particular purpose.**
ALL SALES ARE FINAL. THERE WILL BE NO REFUNDS.
- All announcements made on auction day, whether verbal or by posted signage, supersede all prior announcements, advertising, and catalog listings.
- Catalog descriptions are informational only and are not binding. The auctioneer makes no guarantee that any item conforms to any safety standard or is of the age, make, model, or condition shown in the catalog. NCA does not functionally test equipment, and it is the sole responsibility of the bidder to assess each item's condition and suitability for use. All bidders should perform their own research and due diligence and bid accordingly. If you are uncertain about any item, we strongly encourage you not to bid.
- All risk of loss, theft, damage, and liability for an item transfers to the winning bidder at the moment the auctioneer declares the item "sold," regardless of whether payment has been completed. Title and the right to possession pass to the winning bidder only upon payment in full. **North Country Auctions shall not be held liable for any issue arising after an item has been declared sold.**
- In the event of a bidding dispute, the auctioneer has sole discretion to award the item to the highest bidder or to reoffer the item for sale. The auctioneer's decision is final.
- The auctioneer reserves the right to refuse any bid and to withdraw any item from sale, for any reason, at any time. Items may be offered subject to a reserve price.
- All invoices must be paid in full within 5 banking days of the sale date. Accepted forms of payment are cash, bank check, bank wire, and credit card (subject to Section 8). Any invoice unpaid after 5 banking days may be subject to collection procedures.
- CREDIT CARD POLICY (EFFECTIVE SEPTEMBER 2026).** To help protect our customers and ensure secure payment processing, the following policy applies to all credit card payments:
 - Credit cards must be presented in person with a valid driver's license.
 - Credit card payments cannot be accepted over the telephone.
 - The name on the credit card must match the customer's name listed on the invoice.
 - For security purposes, exceptions to this policy cannot be made.**
We appreciate your understanding and cooperation as we take steps to protect our customers and maintain secure payment practices.
- NO PURCHASES MAY BE REMOVED FROM THE AUCTION SITE UNTIL THE INVOICE AND ANY APPLICABLE STORAGE FEES ARE PAID IN FULL AND VERIFIED. NO EXCEPTIONS.**
- Titles will be processed and mailed via certified USPS, FedEx, or UPS within 4 weeks of the sale date. No titles will be given out on the day of an auction. NCA staff will contact you to confirm title and registration information. Titles will be completed in full to the registered buyer only, whose name must match the invoice. There will be no exceptions.
- All bidders are responsible for researching title information, title history, and retitling procedures for their state of residency prior to bidding. North Country Auctions is not responsible for retitling or for obtaining title or registration information beyond what was provided to North Country Auctions prior to or during the sale, and makes no representations regarding title status or history.
- All non-registerable items are subject to the sales tax rate of the auction location unless a valid tax exemption certificate is provided at the time of payment.
- North Country Auctions is not responsible for any personal injury or property damage caused by a bidder or the bidder's representatives. Each bidder agrees to hold North Country Auctions harmless from any personal injury or property damage to themselves, their property, or any guests or agents attending the auction with them. Children under 18 must be accompanied by a parent, legal guardian, or responsible adult at all times.
- North Country Auctions is exempt from any liability connected with the transport and removal of purchases and any future use of equipment purchased.
- Loading assistance is provided when available as a courtesy and at the bidder's own risk. Loading equipment is not guaranteed to be on site; confirm with NCA prior to pickup. No purchase will be loaded without a paid and verified receipt for all items and any applicable storage fees.
